Policy Name: Recertification for Mobile Critical Care Nurse

Policy Number: 6.4.7-020113

**PURPOSE:** To establish requirements necessary for all applicants seeking recertification and authorization to continue to be credentialed and practice at the Mobile Critical Care Nurse level.

**POLICY:** To ensure consistent standards and procedures for recertifying as a Mobile Critical Care Nurse (MCCN) in West Virginia.

## PROCEDURE/REQUIREMENTS:

- A. Meet all requirements for recertification for Paramedic as well as meet the following requirements:
- B. Apply for recertification between September 30 and December 31 prior to the end of the applicant's certification period.
- C. Apply in a format prescribed by the Commissioner.
  - 1. By completing either an online application or a current updated paper application.
- D. Submit the appropriate fees as required in §64 CSR 48-6.9.
- E. Continuously meet all requirements for EMS personnel as described in §64 CSR 48.
- F. Possess current, unrestricted RN license in West Virginia.
- G. Disclose any limitation or exclusion by any EMS agency, EMS Medical Director, or any other healthcare profession certification or licensing authority in any state, territory the U.S. Military Services.
- H. Possess a valid CPR certification prescribed by the Commissioner.
  - I. If applicant does not have approved fingerprints on file, then the applicant must:
    - Have applied for and been cleared by the State and National background checks for WVOEMS including, but not limited to the following as required in WV Code §16-4C-8.1.1:
    - 2. State and National Criminal background check as directed by the WVOEMS in compliance of WV Code §16-4C-8.1.
    - 3. Child support status.
    - 4. Sexual offender registries.
    - 5. Federal or State medical practice exclusions or limitations.

- J. Complete an Education Determinate Evaluation for Paramedic to identify educational, or performance weaknesses that may need additional educational opportunities. There will be no passing score required on this evaluation.
- K. Flexible education requirements will be based upon performance on Education Determinate Evaluations. Topics also may vary dependent upon educational standards, performance measurements and medical direction topic emphasis as well as other requirements as directed by the Commissioner.
