The course content provides an introduction to a broad span of educational theory that is heavily reliant on brain-based learning and evidence –based best practices for all levels of experience as an EMS Educators Enrollment will be limited to 100 participants. Individuals who attend the entire course and pass the post test will receive a Certificate of Course Completion from NAEMSE with CEU's which is accredited by the Continuing Education Coordinating Board for Emergency Medical Services (CECBEMS).
